Our membership number has been increasing. As of August 2020, our membership has total 231 members including 38 Life Members, 146 Ordinary Members, 9 Fellow Members, 2 Student Members, 17 Corporate Members and 19 Members who joined through participation in the 2019 Photovoltaic Panel System Training Course. There was a growth of 19% in membership as compared with last year.

Training & Education Committee (Chaired by Conson Yu, Co-chaired by Sam Hui and Shelley Zhou)

The 2019/20 term has been a tough one for the Training & Education Committee. Due to Covid-19, some planned classroom training, seminars and technical visits have been cancelled or deferred. But we still play a powerful role in supporting various energy related initiatives and activities.

To promote retro-commissioning, we have supported two technical seminars on this topic. We supported two BEC's EnviroSeries Conference this year and three building related conferences to promote innovation, green building, building operation & maintenance and sustainable building materials. To promote feed-intariff policy and promote renewable energy technology, we support a few technical seminars for professional capacity building workshops in solar PV We plan to launch another professional training for such in the coming term. In total, we have supported more than 25 training and education activities in town for professional development.

While we expect the classroom training and technical visits will be planned and organized as before when Covid-19 is gone, we will explore the different ways to host the training and education programmes and activities online in the coming term.

3. Technical Committee (Chaired by Ringo Shea)

EMSD & FSD jointly held sharing sessions with the stake holders of the industry regarding their proposed Amendment to Subsidiary Legislation of Dangerous Goods Ordinance. The amendment would also cover the use of the high efficiency, more environmentally friendly but flammable refrigerant such as R32 in the AC units, which already appeared in the market.

HKGBC has launched the Retro-Commissioning Registration Scheme in 2019, under which 3 level of practitioners/professional and 3 types of service providers are specified. HKAEE is one of the Registration Committee members. Together with other engineering institutions, we have been providing our professional views and advices to HKGBC for setting up the entire framework and content of training courses for practitioners / professionals registration. Training Courses would be provided by relevant organizations including HKAEE for the interested personnel to prepare for the qualifying examinations held by the HKGBC.

The preparation for the upcoming Technical Forum has been affected by the outbreak of Covid-19 and further follow up work and the date of the event may need to be rescheduled accordingly.

4. Activity Committee (Chaired by H W Yu)

We organized our annual spring dinner on 18 March 2019. The one in 2020 was cancelled due to Covid-19.

Moreover, we jointly organised a technical visit to the International Photovoltaic Power Generation Exhibition Industrial Exchange Tour in Shanghai with CIBSE HK, ASHRAE HK, ACRA and HKAEE on 4 – 7 June 2019

Other than that, a technical visit to Conghua Racecourse and Guangzhou CTF Finance Centre Cum the 11^{th} Guangzhou International Solar Photovoltaic Exhibition has been successfully organized during 16-18 August 2019 with overwhelming participation and very positive feedback by our members.

Apart from the above technical visits, we also participated in many other technical training courses organised by fellow associations and institutions.

6. AEE Liaison Committee (Chaired by K C Tam)

In this session, we continuously maintained a very close working relationship with the AEE-HKC.

All activities, technical visits and seminars were co-organized with the AEE-HKC. We had supported and promoted all their CEM and CMVP course held in 2019 and 2020 with our best endeavor. Simultaneously we received full reciprocal support and assistance from the AEE-HKC in participating our activities. At the end of 2019, the two Associations started to form a special task force working jointly with a target to develop energy related training courses other than the AEE traditional training courses to better suit the local energy industry; and hopefully this could bring additional revenue to both Associations.
