Annual Report for 2024/2025

The Board of Directors (BoD) held five (5) numbers of meetings in this term and I am pleased to report the key activities as follows:

1. Membership

As of August 2025, our membership has total 144 members including 61 Life Members (13 Fellow & 48 Member), 3 Life Corporation Members, 13 Corporate Members, 3 Fellow Members and 64 Ordinary Members. We did have a steady growth of our member number in the past few years.

2. Technical Visits and Exhibition
