

## Training Workshop on “Disclosure of Corporate Value Chain (Scope 3) Emissions”



Reporting on Scope 3 greenhouse gas (GHG) emissions – those originating from corporate but beyond its direct control – will be included as part of required corporate disclosures under new standards developed by the International Sustainability Standards Board (ISSB) of the International Financial Reporting Standards (IFRS) Foundation. The HKEx has also proposed an effective date of 1 January 2024 in alignment with the ISSB with interim provisions for transition. Although the requirements are only applicable to listed companies, the stakeholders along the value chain of the listed companies will be required to collaborate in supporting the disclosure.

Green Council organises and invites professionals who are of environmental, engineering, building management and supply chain management background to join this exclusive interactive training which will explain how to identify the Scope 3 emissions and focus on the hotspots in decarbonisation.
