John is also responsible for the development of the Sustainable Aviation Fuel Standard working in collaboration with ICAO/IATA/JIG. John serves as the Board of Director of several private and publicly listed companies and holds a degree of Chemical Engineering from the University of Toronto and an MBA with University of Durham.


Ms Phoenix Hau Sustainability Manager Ocean Park Corporation
